

# **Edmonton Newsletter**

"What a Difference a Day Makes" was sung by Dinah Washington in her evocative and beautiful voice in 1959 adapted to English by Stanley Adams some 20 years after it was first composed by the Mexican songwriter Maria Grever. Maria did not live to hear Dinah take her song and give it the universal popularity it enjoys today and continues to inspire numerous cover versions by others over the years.

What a difference a day made
Twenty-four little hours
Brought the sun and the flowers
Where there used to be rain
My yesterday was blue, dear
Today I'm part of you, dear
My lonely nights are through, dear
Since you said you were mine

As we continue to celebrate the day that made all the difference to this world, and to our lives, the day that continues to bring change to those who follow us, the words of this song capture something of the longing and desire that for many in our world cannot be met by the substitutes for God that have been



embraced by so many. The poignant longing within Dinah's voice connects with the desperate longing of many in a world of violence, hopelessness and death and can be heard to be a love song for the one who in "24 little hours" changed my "yesterday's blues".

As Mary Magdalene seeks to embrace our Lord in the early light of the first 24 hours of Easter, through the tears of her loss and grief, she is prevented by our Lord from touching him. I have always wondered how a moment so open to an interpretation of cruel indifference to the obvious distress and need of another for physical reassurance is never less recorded by St John in his account of Easter.

Surely the image of one who has lost everything, who faces a future without her Lord, and for whom her natural reaction upon realising he is now standing before her can resonate with our deep longing for a happy end to any story or drama of life but here the end is not an hope-filled embrace but with the words from the risen Jesus "Do not touch me'. How do I reconcile this with the God-in-man who touched those others scorned, who touched the unclean dead, who allowed another woman to touch him and anoint him, who took with a gentle touch, as many of us as clergy will have done on Maundy Thursday, the feet of his disciples as a sign of his love for us and gave us the commandment to do the same for one another.

The lyrics of the song "since you said you were mine" seem to mock the encounter between Mary Magdlene in the dawn of a new day, by not allowing for these words to be followed by the action encapsulating the most human of needs – an embrace when "yesterday was blue and the lonely nights were through".

Understanding this encounter as a sign, St John's gospel is full of signs, may bring an answer to my dilemma. For what this encounter, this thwarted embrace signifies is that Mary belongs with her Lord but now in a different way. Having heard her own name spoken Mary realised that no longer is she in the presence of a gardener, or a stranger, but she is once again in the presence of Jesus who has fulfilled his Father's desire, broken the power

of evil and is now glorified as promised in the preceding chapters of the gospel. The moment of belonging is for Mary Magdalene the moment of knowing that amidst the "sun and flowers" a new relationship with Jesus is now opening before her.

It is in his commentary on John's Gospel that Prof David Ford reflects on this encounter between Mary Magdalene and the Risen Jesus. He observes "There is a new form of relationship with Jesus, no longer based on physical contact and seeing him in the flesh. Instead, there will be an ongoing permanent relationship with him in his relationship with the father". The evidence for this claim is in the content of the message that she is now charged with delivering to the disciples, her brothers, and for which she was viewed and described by St Thomas Aquinas as "the Apostle of the Apostles". Go instead to my brothers and tell them, 'I am ascending to my Father and your Father, to my God and your God.""

Could it be that what I crave in this life is to be found in Jesus and the Father, My God and your God and the embrace, the physical reassurance of belonging is to be found in his community of believers? If this is so then it is in this embrace, this belonging that I become part of "the rainbow before me" and the truth is once again affirmed in the last halting words of Dinah Washington "What a difference a day made and the difference is you, is you, is you."

I pray that we will continue to discover that it is the embrace and holding of each other that we best show the love of God in Christ Jesus in this world. As we continue to live in a time of deep unhappiness within the church, a time of fragmentation in our communities with competing claims for truth, I hope and pray that we can still find a way to love as we have been commanded by washing each other's feet, as we strive to serve our Lord.

# All Saints Edmonton Attracts Funding from The National Lottery Heritage Fund

The PCC of All Saints Edmonton is delighted to have been awarded a grant of £215,833 from The National Lottery Heritage Fund to support their project 'Reviving All Saints in the Community.' The project seeks to revive and develop relationships between All Saints and wider Edmonton communities, improving the PCC's understanding of local need, and involving a wide range of people in the delivery of the NLHF project. The goal is to establish an inclusive and sustainable future for the historic Grade II\* listed church, based on local need and support.



The project will deliver a range of heritage activities, including opportunities for young people to gain transferrable skills, enhance their CVs and engage in heritage workshops on building maintenance and stonemasonry. An oral history strand will capture 'Windrush' memories, and first impressions of All Saints- its ancient fabric and light filled interior- and reflections on what the building has come to mean to that community now. Year 5 pupils will be given an opportunity to learn about migration and will receive guidance on how to confidently interview an older generation. Urgent stonework repairs will be undertaken to the South chapel parapet, during which the community will be invited to learn more about the approach.

All Saints is Grade II\* listed and included on Historic England's Heritage at Risk Register. Dating from the 15th century, it represents the ancient heart of Edmonton, and contains fine monuments, 19th century wall paintings and stained glass. An Open Day, Community Meal and volunteer research project will give as many as possible an opportunity to enjoy and understand its beauty, history and heritage.

The project has had welcome support from the Diocese of London Parish Property Team and attracted local funding from the Enfield Society; the Ecclesiastical Charities of John Wild of Edmonton & Others; and Untold Edmonton, a major cultural engagement initiative for communities within Enfield.

The Ven John Hawkins, Archdeacon of Hampstead, said: "All Saints Church is one that is committed to reaching out and working for the transformation of their community with its many challenges. The grant of £215,833 from the Heritage Fund is valuable recognition of All Saint's desire and hard work to do this. Through maintaining and celebrating the historic fabric of Edmonton this project will ensure that the valuable church building can remain open for future generations to enjoy and benefit from. It will also help to realise All Saint's vision for the lives of local people, in particular young people, to be transformed, including by honouring the contribution of those who came with their energy and hopes to this community, at a time of significant need and change - the Windrush generation."

Mother Roxane Liddell, Vicar and Chair of the PCC, said: "Everyone at All Saints is delighted that The National Lottery Heritage Fund has supported our project. The grant will allow us to continue to build stronger links with our partners and the community as well as creating a space where a record of the lived experiences of the Windrush generation is explored and recorded through our intergenerational project. There will also be opportunities for young people to gain life skills, which they can take with them as they move from education into the workforce, university or apprenticeships. The grant will allow us to begin addressing the urgent repairs needed to ensure All Saints continues to be a place of welcome for all living and visiting Edmonton. All Saints has been part of Edmonton for nearly 900 years and we are grateful to the National Lottery players for their help in ensuring it remains a special place for all."



Dave Cockle, Chair of The Enfield Society, said: "Our Society works to conserve and enhance the heritage and environment of our borough. Both the building and the community of All Saints are an important part of the heritage and social fabric of Edmonton, and we are delighted that this has been recognised by the Heritage Fund. We are very pleased to be supporting a project which will enhance the church itself and make its rich history and significance better known."

# Youth Work and Adult Art for Wellness Outreach at St Augustine Grahame Park

Esperanza Walsh, Youth Worker at St Augustine Grahame Park writes: It all started five years ago, when we received a grant from the Laing Family Trusts. Owing to this generous donation, our youth work and adult art for wellness outreach has proven very fruitful for the past few years. We engaged with people in the community through art activities for children and for adults. From a small number of participants, in our after-school watercolour workshops, Sunday school and art for wellness for adults, we now have a stable number of attendees and are still growing in number. We have now good friends from Orion Primary School and Beaufort Part estate, both of them are part of our 'mission



of love'. We are trying to circulate 'the Christian brand', the joy and fellowship of the Kingdom of God.

Changes brought about by the Covid-19 pandemic proved to be very challenging but we remained committed and quickly adapted the delivery of our programs to an online platform. At the time, we made the recordings of these workshops available online through our YouTube channel. When the lockdown eased, we migrated the programs back to face-to-face delivery to cater for the needs of the community. All this is partnership with one of the mission enablers from the diocese, Philip, who lives in Beaufort Park. We developed a good relationship with the estate management, and Saint Augustine's church became part of the local life (concerts, workshops). These activities also created a small adult community, which regularly meets in the local pub (Beaufort's Young), or in our 'Bible Mental Health Wellbeing Group'.

Christian values are at the forefront of all of our activities. These activities are geared to encourage and support inclusivity and develop the creative gifts God has given us. It is wonderful to 'play together' as God's children. All this can give some ideas how to engage with the 'unchurched' by addressing young parents with children, or adults, living in old or modern housing estates.

# **GMH/UKME Mentors Urgently Needed**



Mentoring is crucial in the development and growth of individuals, regardless of vocation. The Racial Justice Unit is looking to identify GMH/UKME mentors to guide and support GMH/UKME lay leaders and ordained ministers in navigating the challenges and complexities of their vocational journey. # Could You or Someone You Know Become a Youth Apprentice?

The Apprentice Programme aims to develop missional activities among children and youth by training up new people from within church communities across the Diocese of London over the course of three years. Apprentices are employed by the Diocese of London, and work under the direction and support of a church's leadership team to begin, establish or develop the youth and/or children's ministry in that church. Apprentices also study Theology, Ministry and Mission with Ridley



London, the London training centre of Ridley Hall Cambridge. They are paid the London Living Wage and gain valuable experience of church ministry with children and young people.

We've opened recruitment for 10 new youth and/or children's apprentices to start training this September. Apprentices receive three years of learning on the job, growing their confidence and skills whilst making an impact. The best bit is that apprentices pay nothing towards getting their Cert HE in Mission and Ministry with Ridley London. The programme is open to churches in the Diocese of London with someone already in mind from their community.
